Summary

I am Vice President and Pro-Vice Chancellor (Faculty Development) and Professor of Philosophy, Logic, and Scientific Method at the London School of Economics and Political Science. My research concerns three aspects of justice: distributive justice—who should get what; relational justice—how people should interact with each other through social and political institutions; and procedural justice—how social and political decisions should be made. Across these areas, I have developed egalitarian views and traced their implications for health policy. While my expertise is in political philosophy, my work is interdisciplinary. I have undertaken empirical research and co-authored papers and policy reports with colleagues in economics, health policy, law, political theory, psychological and behavioural science, and public policy, as well as with policymakers from around the globe. This policy work has contributed to more egalitarian methods of priority setting in health and more open and inclusive methods of making health policy decisions. I also have research interests in moral psychology, decision theory, and Epicureanism.

I am an innovative and effective academic leader, with a collaborative style, tenacity, and an eye for detail. The four interdisciplinary degrees (and several courses) I developed at LSE, and my service as Head of Department, have more than doubled the size of LSE Philosophy and helped establish it as one of the world's best departments. I serve on the School's Management Committee, and lead on all aspects of hiring, career development, and promotion of academic staff. I have implemented substantial changes to the structure of career development and contribution pay, with the aim of ensuring that colleagues at every career stage are stimulated, supported, and incentivized to do their best work. I have also developed changes to the hiring and promotion on the Education, Policy, and Research Career Tracks at LSE.

Together, these have expanded teaching and professional services staff in my department by more than 10 FTE (doubling its size), and across the rest of the LSE by around another 7 FTE.

My arguments for a pluralist egalitarian view of distributive justice influenced a landmark report by the WHO's Consultative Group on Equity and Universal Health Coverage, on which I served from 2012 to 2014. The report's principles were endorsed in full by the WHO Director-General and have shaped WHO guidance. They have been adopted to guide health resource allocation in many countries, notably in Latin America, Norway, and Ethiopia. This policy impact was the basis of one of my Department's Impact Case Studies for the UK Research Excellence Framework 2021, which was selected by the British Philosophical Association to showcase the value of philosophy. I have also co-authored a background paper for the WHO/OECD's report on how to evaluate social and movement measures during the pandemic. Finally, I am one of the authors of a World Bank/Norwegian Institute of Public Health report on fair health financing, which has received extensive attention from policymakers and which, together with the underpinning research by a large team of which I was a member, led to a World Health Assembly resolution on social participation in health being passed in 2024, as well as actions in several countries. This work forms the basis of a draft Impact Case Study for REF 2029.
