is Associate Professor of International Relations at LSE and the Research Director of the Grantham Research Institute on Climate Change and the Environment.



## **Professor Tomila Lankina**

is Professor of International Relations at LSE. Her expertise is on democratization, sub-national governance, Russia, Central Europe, Eurasia, India, and legacies of colonialism.



## **Professor Karen E. Smith**

is Professor of International Relations at the LSE. Her area of expertise includes foreign policy analysis, international organisations (particularly the EU and the UN), and human

# The Practitioners

The team of practitioners is formed by experienced strategists, diplomats and civil servants. Their strategic and diplomatic experience ranges from the Foreign Office and Number 10 to NATO and the EU, GCHQ and the UK National Security Council, and international business and finance. Through sharing their invaluable first-hand experience, they enable participants to develop a practical approach to the issues covered by the programme.



## HEAD OF PRACTITIONERS

**Hugh Sandeman** leads the team of practitioners. He is a Visiting Senior Fellow at LSE IDEAS and Project Head of Global Strategies. He was an international banker for 30 years, based in New York, Tokyo, London and Frankfurt, and for the past decade has focused on India. He was previously Tokyo correspondent, international business editor and New York correspondent of *The Economist*.



**Professor Wang Jisi** is Professor in the School of International Studies and president of the Institute of International and Strategic Studies, Peking University. He is honorary president of the Chinese Association for American Studies, and was a member of the Foreign Policy Advisory Committee of China's Foreign Ministry in 2008-2016.



**Sir Richard Mottram GCB** is an expert on defence, security, strategy and planning. He was one of Britain's top civil servants, heading several departments, including the Ministry of Defence, and Security and Intelligence in the Cabinet Office. His current roles include Chairman of the Defence Science and Technology Laboratory.



**Sir Malcolm Rifkind KCMG KC** was a Conservative Member of Parliament from 1974-1997 and 2010-2015. Sir Malcolm has been a member of the British Cabinet as Secretary of State for Scotland and for Defence. He was Foreign Secretary from 1995-1997, and between 2010 and 2015, he was Chairman of Parliament's Intelligence and Security Committee.



**General Sir James Everard KCB CBE** is a senior British military leader who was Deputy Supreme Allied Commander Europe (NATO) in his final appointment before leaving the Army in 2020. He joined the 17th/21st Lancers in 1983, spending his early years in the Army with tank units in the British Army of the Rhine. He then commanded The Queen's Royal Lancers, the 20th Armoured Brigade and the 3rd Division, and served as the Assistant Chief of the General Staff.



**Dame Judith MacGregor DCMG LVO DL** was the British High Commissioner to South Africa from September 2013 until March 2017. She was FCO Director for Migration in 2007, Ambassador to Mexico in 2009, and President of the FCO Women's Association from 2006, overseeing a significant increase in the number of women who became senior British diplomats.



**Suzanne Raine** served in the UK's Foreign, Commonwealth and Development Office from 1995-2019. This included postings in Poland, Iraq and Pakistan. She specialised in counter-terrorism, holding a number of senior domestic appointments including Head of the Joint Terrorism Analysis Centre from 2015-2017 and Director Counter Terrorism from 2017-19.

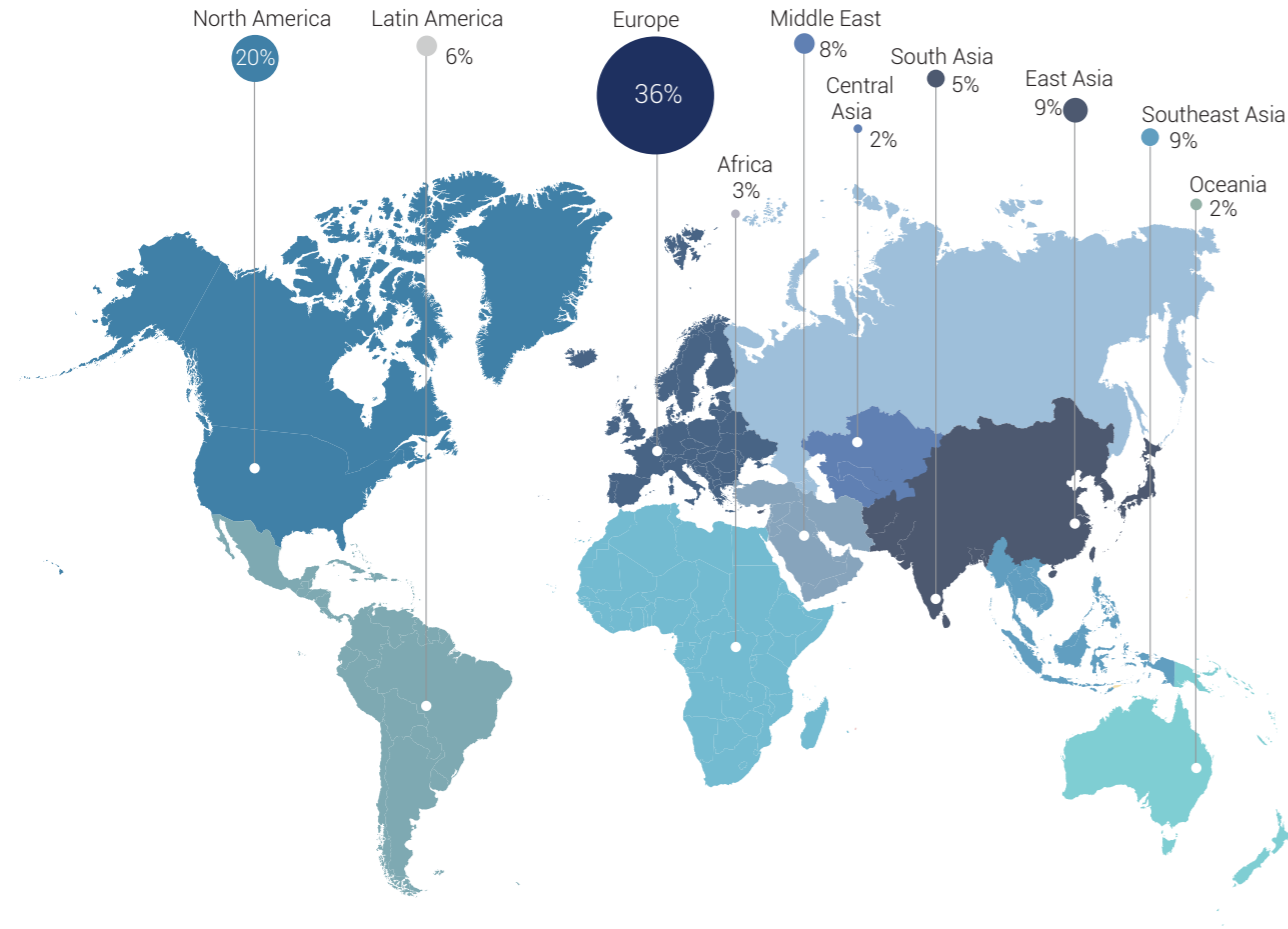

Percentages include both past and current participants.

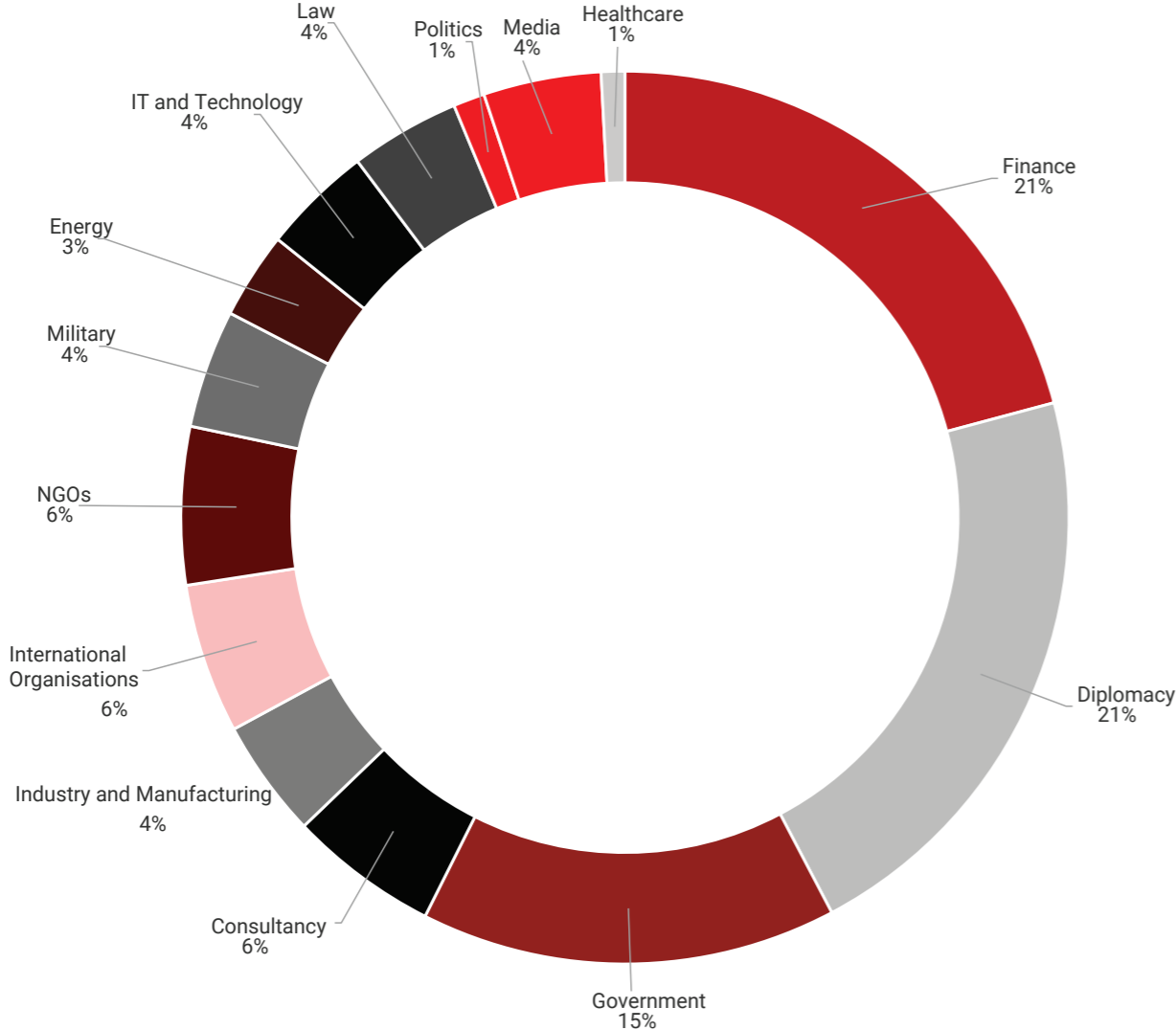

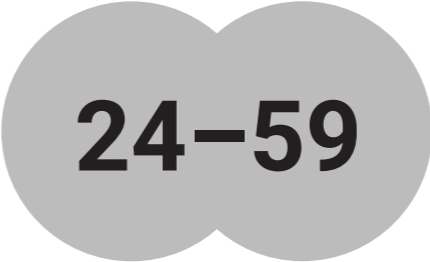
## By Profession

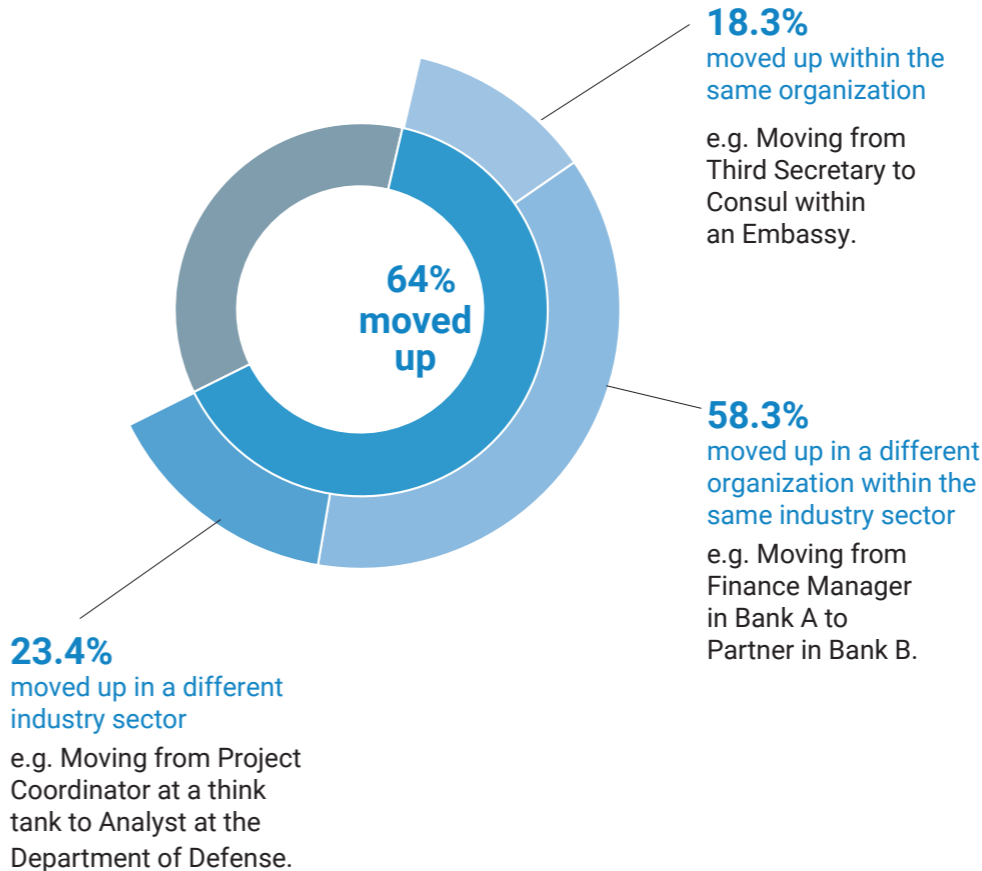
# Alumni Career Progression

# Application Process and Fees

## Entry requirements

The programme is designed for senior and mid-level diplomats, civil servants, military officials, international NGO employees as well as executives from international firms and corporations (finance, consultancy, manufacturing, technology). You will be required to have:

- A 2:1 degree or equivalent in any discipline (preferably in politics, history, international relations or a similar discipline)
- A minimum four years' professional experience

If English is not your first language, you should possess an English language qualification such as IELTS or TOEFL, awarded within the last two years. Minimum scores required are:

- IELTS—overall score of 7.0 (7.0 in reading and 6.5 in listening, writing, and speaking), or
- TOEFL—overall score of 100 (25 in reading, 24 in writing and 22 in listening and speaking).

## How to apply

Candidates are considered on a rolling admissions basis, as early as November for the following September intake. However, we recommend applying as early as possible as there is high competition for places.

To be considered for this programme, you will need to apply using the online application form. You will be asked to write a personal statement, setting out why you are interested in the programme, highlighting your relevant experience and suitability for the programme and your future plans. In addition, you will need to attach your university degree certificates and transcripts, and two professional or academic references.
