### Module 1 Information

There are a number of items you will need to complete to make sure you are fully prepared for your arrival for module 1. ### What is the easiest way to travel into the city?

### What are my accommodation options for the module?

Suggestions on accommodation options are detailed further on in this booklet so do read this carefully.

It is your responsibility to book and arrange accommodation for the modules.

#### Do I need a visa?

You may need a visa to attend teaching modules for this programme - please read the information further on in this booklet for more details.

### Do I need to provide any further admissions documents before arrival?

Your offer letter would have included information on what documents you still need to provide in order to be able to enrol on campus. These might include original or verified copies of your transcripts or references. As far as you can, we would encourage

you to send these electronically, ie. emailed directly from your previous institution to <code>graduate.documents@lse.ac.uk</code>, or from an official online service, such as HEAR, Digitary, GMAT, or TOEFL. If you do not provide all of your outstanding documentation, either beforehand or during enrolment, you will not be enrolled and if you are not enrolled, <code>you cannot attend classes</code>. Providing your documents in advance avoids any complications when you arrive. You can check the Graduate Application Portal (GAP) to see what you have outstanding.

#### When will I be enrolled?

We will be enrolling you on campus on the first day of module 1 – we will send you more information on this in due course.

### Do I need to bring all the textbooks and reading materials?

All required readings are provided on the online reading lists on Moodle with clear instructions on what is essential reading for each session and what can be completed after the module.

In general, we do not provide hard copies of readings and slides, as they are available electronically via our intranet. We would therefore recommend that, if you prefer printed materials, you bring these with you (if needed).

### **Moodle and General Resources**

A few months before the programme starts, once we have received your pre-registration fee, you will receive access to our online intranet, Moodle.

Each course on the programme will have a Moodle page where you will have access to all readings, materials and other relevant information. Moodle is also where assignments will be posted and submitted. There is also a General EMSBE Moodle page, which contains a lot of general information and resources about the programme. You will be given instructions on how to enrol on each Moodle course and once you have access, must read the information on each course carefully.

Please also note that you **will not** receive a CAS number for this programme, as these are not required for Standard Visitor visas.

### And finally....

Please remember it is vital that you have the correct permission to study before arriving for the programme. During module 1, you will attend campus enrollment where your documents will be checked. If you do not have the correct visa, **you will not be enrolled and if you are not enrolled, you will not be able to attend any teaching sessions**. The School must abide by UK immigration procedures, so there are **no** exceptions to this rule. Even if you think you do not require a visa, please read the information at the links above to confirm this.

### Fees and Financing

The fees for the programme are £36,000 in total and are the same for all students, regardless of if you are classified as an Overseas or Home/EU student. Please note your pre-registration fee of £2,500 will be deducted from your overall tuition fee.

Students on this programme are not eligible for LSE scholarships (including the LSE Graduate Support Scheme), as the programme is designed for students to continue working and earning a salary while they study. However, the Marshall Institute has scholarship funding available for outstanding candidates who are unable to meet the full cost of tuition. ### **Financial Undertaking Form:**

You must make sure you have completed this prior to arrival for orientation as if you have not submitted it, you will not be able to enroll. Details on this can be found in the Graduate Application Portal (GAP).

### **Faculty Bios**

### **Professor Stephan Chambers**

Stephan Chambers is the inaugural director of the Marshall Institute at LSE. He is also Professor in Practice at the Department of Management at LSE and Course Director for the Executive Masters in Social Business and Entrepreneurship.

From 2000 to 2014 he directed the University of Oxford's MBA, overseeing its rise in international influence and rankings. In addition, he was the founding Director of Oxford University's Executive MBA programme.

Before joining the Marshall Institute Stephan Chambers was the Co-Founder of the Skoll World Forum, Chair of the Skoll Centre for Social Entrepreneurship and Director of International Strategy at Saïd Business School, Oxford University.

He is a Senior Research Fellow at Lincoln College, Oxford, sits on the advisory board of Princeton University Press, and is a Director of the Britdoc Foundation, the Dartington Trust, the University of the People, and the Dragon School.

Stephan Chambers wrote a regular entrepreneurship column for the *Financial Times* and, in 2014, was special advisor to Larry Brilliant and Jeff Skoll at the Skoll Global Threats Fund in California. He teaches entrepreneurship, social entrepreneurship and entrepreneurial finance.



### **Dr Kerryn Krige**

Kerryn joined LSE from the International Labour Organization where she led the development of the social and solidarity economy (SSE) policy in South Africa. She has contributed to various social entrepreneurship initiatives including the SSE strategy for the African Union, two mapping studies of social entrepreneurship in South Africa, and the development of South Africa's USD70 Social Employment Fund. Prior to this, Kerryn led the Network for Social Entrepreneurs at the University of Pretoria's Gordon Institute of Business Science. She has held positions on various CSI and development finance boards, and is a trustee to accreditation authority, the Social Enterprise Mark CiC. Kerryn is an Associate Editor for Emerald Emerging Markets Case Collection and has guest edited two Special Collections on social entrepreneurship in Africa. She is co-author of the book The Disruptors, social entrepreneurs re-investing in business and society.

Kerryn has received numerous fellowships and is actively involved in the African Network of Social Entrepreneurship Scholars (ANSES) which promotes the development of a relevant and localised teaching and research agenda in Africa for social entrepreneurship. Her PhD, from KU Leuven and the University of Pretoria, focuses on social entrepreneurship in difficult market, institutionally void, contexts.





#### **Professor Jonathan Roberts**

Jonathan Roberts is Teaching Director and Senior Lecturer in Practice at the Marshall Institute. He leads the development of teaching activities at the Institute, including the Executive Masters in Social Business and Entrepreneurship and a Marshall Institute specialism within LSE's Master in Public Administration programme, the MPA in Social Impact.

Jonathan holds a PhD from the Department of Social Policy at LSE, for which he received the Titmuss prize. He has taught and lectured at LSE on behavioural public policy, on social enterprise and on the relationship between government and the voluntary sector. In addition to his work at the Institute he teaches Nonprofit and Voluntary Sector Policy and Management at the School of Public Policy, UCL. He is a classicist by training, having received a BA (Hons) in Classics from the University of Cambridge. Prior to joining LSE he worked for a number of UK charities, a set of experiences which raised significant questions about the challenges and opportunities of private action for public benefit and which stimulated his academic teaching and research.

Jonathan's research interests include motivations and altruism, trust in public services, and the role of social enterprises and mutual organisations in public service delivery. He has a particular interest in education, pre-school and family policy. His doctoral research explored how parents trust pre-school childcare provision. He has recently completed a study of young adults who co-reside with their parents post-university (the so-called "boomerang generation"), and was a major contributor to a study of European philanthropic foundations. He is currently researching public service mutuals and children's centres. His work has been published in social policy, education, sociology and public administration journals.

Jonathan serves on the governing body of a state primary school in south London and on the advisory committee of the Pen Green Research, Development and Training Base in Northamptonshire.



#### **Professor Connson Locke**

Connson Chou Locke joined the Department of Management in 2008. She teaches courses in organisational behaviour, leadership, and negotiation and decision making. In 2013, she received the Department of Management Outstanding Teaching Contribution Award and in 2015 she was Highly Commended for Inspirational Teaching in the Student- Led Teaching Excellence Awards. Professor Locke holds a PhD and MSc in Organisational Behaviour from the University of California, Berkeley and a BA in Sociology from Harvard University where she graduated with honours.

Before entering academia, Professor Locke worked for 16 years as an educator, manager, and management consultant in the United States and Asia Pacific. She was the Asia Pacific Regional Training and Development Manager for the Boston Consulting Group where she oversaw the learning and development of consulting staff across the region. Professor Locke has extensive experience designing and teaching leadership development programmes and providing executive coaching. She has worked in nearly 20 countries across Europe and Asia Pacific as well as in the United States and Australia.

Professor Locke currently teaches on, and holds director level positions, with two high-level executive education programmes at LSE: the Executive Global Masters in Management and LSE's successful programme of short executive education courses aimed at senior professionals.





### **Professor Sir Julian Le Grand**

Julian Le Grand has been Professor of Social Policy at the London School of Economics and Political Science since 1993. He was awarded a knighthood in the 2015 New Year's Honour's list for services to social sciences and public service.

He is an economist by training, with a PhD in economics from the University of Pennsylvania. He is the author, co-author or editor of over twenty books, and more than one hundred refereed journal articles and book chapters on economics, philosophy, and public policy. He has taught at the Universities of Sussex, Bristol and California, Santa Barbara, as well as LSE.

He is a Fellow of the British Academy, a Founding Academician of the Academy of Social Sciences, and an Honorary Fellow of the Faculty of Public Health Medicine. He was a Trustee of the Kings Fund from 2007 to 2016. In 2006 he was awarded an honorary doctorate (DLitt) by the University of Sussex. In 2012 he was awarded the Eupolis Prize for Public Policy by the Eupolis Institute, Milan, and his submission for the Wolfson economics prize received "a special category" prize.

From 2003 to 2005 he was seconded to No 10 Downing St to serve as Senior Policy Adviser to the Prime Minister. In 2007 he was Chairman of the Social Work Practices Working Group for the UK Department for Children, Families and Schools. From 2007 to 2009 he was Chair of Health England: the National Reference Group for Health and Well Being for the UK Department of Health. From 2011 to 2013 he was Chair of the UK Cabinet Office's Mutuals TaskForce. In 2013 and 2014 he was the Chair of the Panels reviewing Doncaster's and Birmingham's Children's Services for the Department for Education and wrote the Panels' reports.

As well as these positions, he has acted as an adviser to the President of the European Commission, the World Bank, the World Health Organisation, the OECD, HM Treasury, the UK Department of Work and Pensions and the BBC. He has been Vice-Chairman of a major teaching hospital, a Commissioner on the Commission for Health Improvement, and a non-executive director of several health authorities. He has served on many National Health Service working parties, on several think-tank commissions and on two grants boards for the Economic and Social Research Council.

He is one of the principal architect of the UK's public service reforms, empowering users and introducing contestability into health care and education. His other policy innovations include the Pupil Premium for the less well-off and for looked after children, now government policy; the Social Work Practices established by the Department for Education and the Department of Health; Patient Budgets piloted by the Department of Health; the Partnership Scheme for funding long term care endorsed by the 2005 Wanless Report Securing Good Care for Older People; and the Child Trust Fund, government policy from 2002-2010.




#### **Dr Eva Neitzert**
