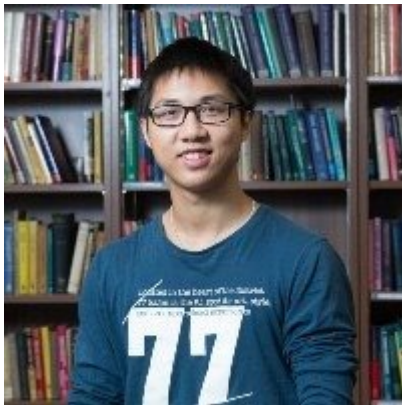

Camilo Cárdenas Hurtado has been recommended for a PhD award.



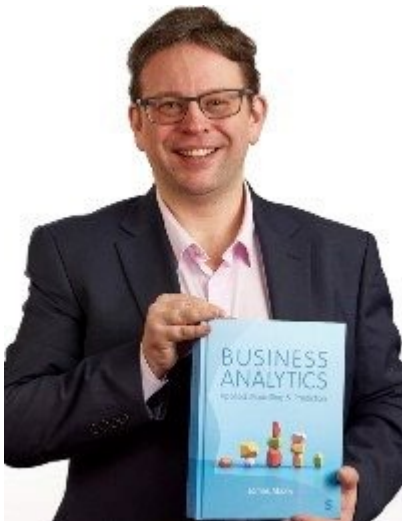

Professor Barrieu highlighted in an exhibition in Paris.

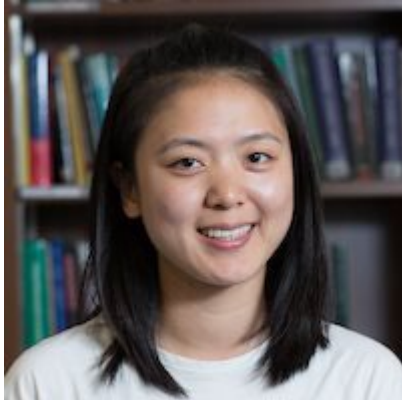

A HUGE well done to our lovely Statistics students Poh Lim and Alfie Worth for winning the Outstanding Academic Achievement award!

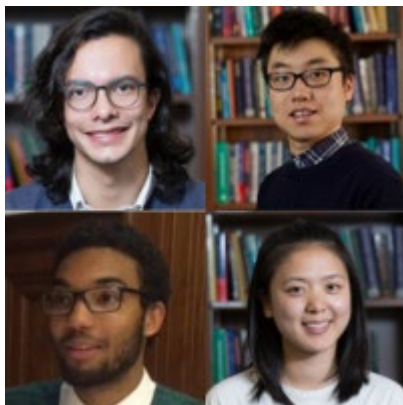

We wish Yufei Zhang, Daniela Escobar and Marwah Soliman all the best in their new adventures. You will be missed in the department and please keep in touch!

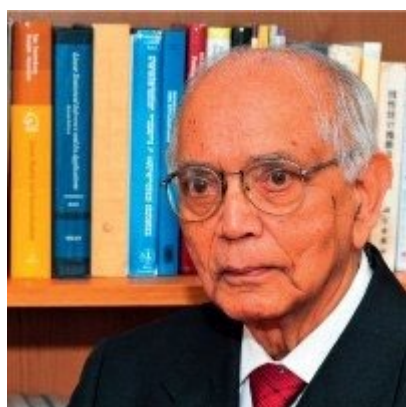
Yufei has these parting words:

New PhD Studentship - *Assessing inequality in the Criminal Justice System* - Deadline extended. We are delighted to be hosting one of new 20 studentships funded by [ADR UK \(Administrative Data Research UK\)](#) focusing on quantitative research using linked administrative data.

The funded project, *Assessing Inequality in the Criminal Justice System using statistical methods*, will be supervised by [Dr Sara Geneletti](#) and [Professor Fiona Steele](#).

The studentship will cover tuition fees and provide a maintenance stipend for 4 years.

About the project:

The Lammy Review showed evidence of discrimination in the Criminal Justice System. The aim of this project is to use causal inference methods to corroborate these findings by quantifying the impact of discrimination in sentencing using Data

First: Criminal Justice System Linked Datasets.

Eligibility:

- This studentship is open to candidates of all nationalities.
- Applicants should expect to complete / have completed a taught MSc in Statistics, Mathematics or a related discipline (e.g. Economics, etc.) or equivalent, plus an undergraduate degree of good standing.

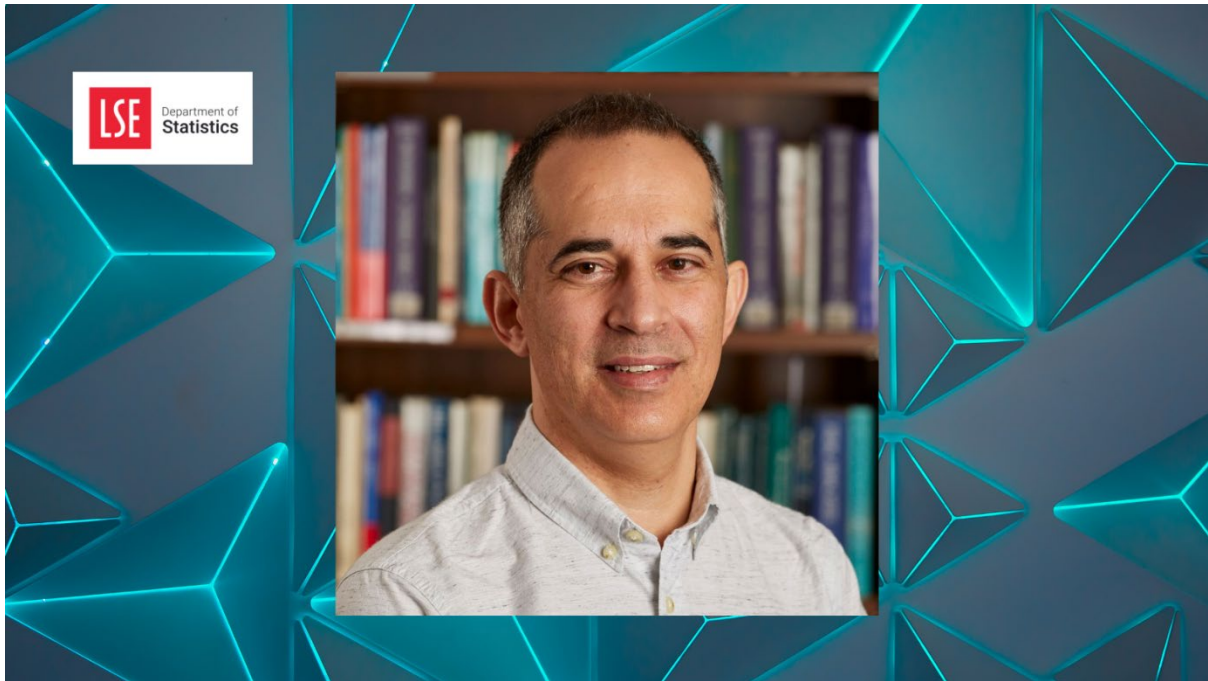
The application deadline is 27 July 2023, which has been extended from April.

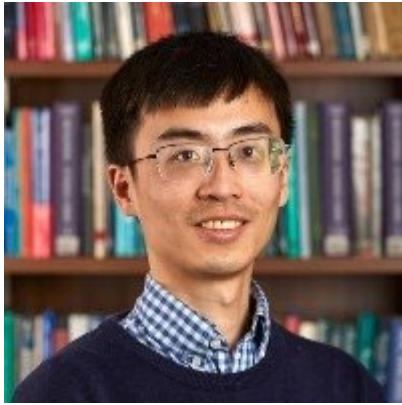

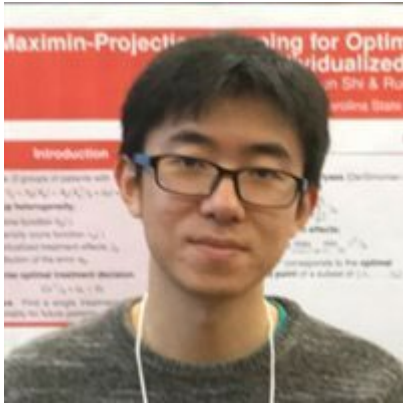

Dr. Giulia Livieri's successful Innovation Challenge idea!

The innovation challenge is a call for LSE researchers to develop ideas based on their research to help meet the challenges faced by the world in a time of rapid change. It's for all engaged in academic research across LSE's departments/centres – academic, research and policy staff. The LSE Innovation (LSEi) review panel decided that Giulia's application has commercialisation potential and should be supported by the Innovation team. In addition, the panel has offered an award of £5,000 to Giulia to be used for market validation purposes.

The summary of her venture idea is Climate Change, Uncertainty and Financial Risk: Robust Approaches based on Time-Varying Parameters. Giulia would like to develop

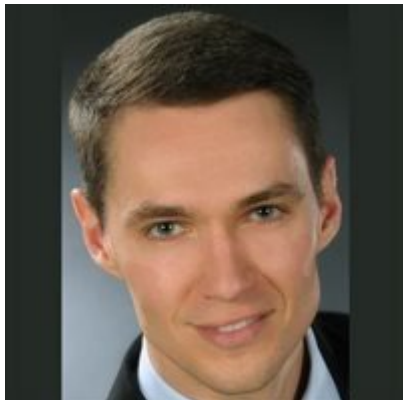
novel econometric approaches to assess and manage climate risk in big financial portfolios in a robust, easily implementable, and flexible form. She will adopt the view that the parameters governing the impact of climate shocks on asset prices are latent and random, reflecting the uncertainty of future climate scenarios. Because climate-related shocks are non-stationary, she will allow for temporal variations in the parameters' conditional distributions, and plans to construct dynamic models of different forms, e.g., time-series, cross-sections, and networks, describing the concentrations of climate risks in the portfolio and the firms' time-varying exposure to such risks. By aggregating the latter at the portfolio or the financial system level, she will perform stress test and scenario analyses of systemic risk.
