Campus enrolment

MA400 Pre-sessional Course - 9 to 20 September

The compulsory pre-sessional course MA400 will run for two weeks from Monday 9 to Friday 20 September 2024. All students are expected to attend this course in person. There is also an informal online exam which will take place at the end of the pre-sessional course on Wednesday 25 September. You will receive a mark, but it is not formally recorded and will not appear on your transcript or affect your classification at the end of the degree. This exam is intended merely to give you with some general feedback on your understanding of the material covered which will be invaluable for learning.

R Pre-Sessional Course

Previous programming experience is helpful for the compulsory course <u>ST429 Statistical</u> <u>Methods for Risk Management</u>. If you have no previous experience in R, you are strongly advised to complete the online course on Moodle.

Python Pre-Sessional Course

The course will equip you with the basics of the Python programming language and environment, to enable you to follow other courses in the Statistics Department (including MA417), many of which will assume prior knowledge of Python up to the level of the course.

It is strongly recommended that you take the Python course if you do not already have prior knowledge of Python.
